RESOLUTION 10-01-58-02

**A RESOLUTION TO RESCIND LEASE AUTHORIZED BY
RESOLUTION #03-36-85 FOR [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #03-36-85, authorized a tribal land lease to be given to [REDACTED] for the purpose of establishing a home; and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective July 9, 1985, for the property described herein; and,

WHEREAS, said land is described as follows:

That part of the NE ¼ of NW ¼ of Section 17, Township 43N, Range 23 W, of Aitkin County General Development Survey – Lot 6; and,

WHEREAS, [REDACTED] is deceased and there is no home currently located on the site described herein.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the rescinding of the lease authorized by Band Resolution #03-36-85; and,

BE IT FURTHER RESOLVED, that the land will revert back to the Mille Lacs Band of Ojibwe for lease to another Band member.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 9th of May, 2002 at Hinckley, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
