RESOLUTION 10-02-68-02

**A RESOLUTION TO RESCIND LEASE AUTHORIZED BY
RESOLUTION #07-83 FOR [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, resolution # 07-83 states that resolution # 22-81 is not definitive in the land description of [REDACTED] and

WHEREAS, the resolution number 22-81 is a typographical error and should read 22-80; and

WHEREAS, Resolution #07-83 amended Resolution 22-80 which authorized a tribal land lease to be given to [REDACTED] and [REDACTED] for the purpose of establishing a home; and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective December 10, 1979, for the property described herein; and,

WHEREAS, said land is described as follows:

A part of Tract # 410 T33 described as follows:

Lot 6, Block A33 as defined by the Vineland Hills Map as part of the N ½ of the NE ¼ of Section 28, Township 43 North, Range 27 West, map dated March 9, 1982, Fourth Principal Meridian, Mille Lacs County, Minnesota; and,

WHEREAS, [REDACTED] passed away on November 29, 1986; and

WHEREAS, the house and the leasehold interest is held by Minnesota Chippewa Tribal Housing Corporation and they have entered into a contract for purchase of the house for the site described herein with [REDACTED]

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the rescinding of the lease authorized by Band Resolution #07-83; and,
