**JOINT-RESOLUTION 09-04-12-02**

**A RESOLUTION GRANTING A ROLL CORRECTION (confidential)**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Mille Lacs Band Assembly screens all membership considerations and has reviewed the following recommendation for roll correction; and


WHEREAS, it has been determined that Mille Lacs enrollee Fawn Lynn Marie Thomas, born [REDACTED] blood degree [REDACTED] was erroneously placed on the Mille Lacs Non-Removable rolls at the time of her acceptance on 10-29-92, by the Minnesota Chippewa Tribal Executive Committee; and

WHEREAS, it has been determined that Fawn Lynn Marie Thomas should have rightfully been placed on the White Earth Reservation rolls, with a blood degree of [REDACTED]

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly does hereby recommend to the Tribal Executive Committee that this roll correction be approved and that Fawn Lynn Marie Thomas be removed from the Mille Lacs Reservation rolls and placed on the White Earth rolls, which is her rightful membership.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 16th day of October, 2001 at Lake Lena, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT
