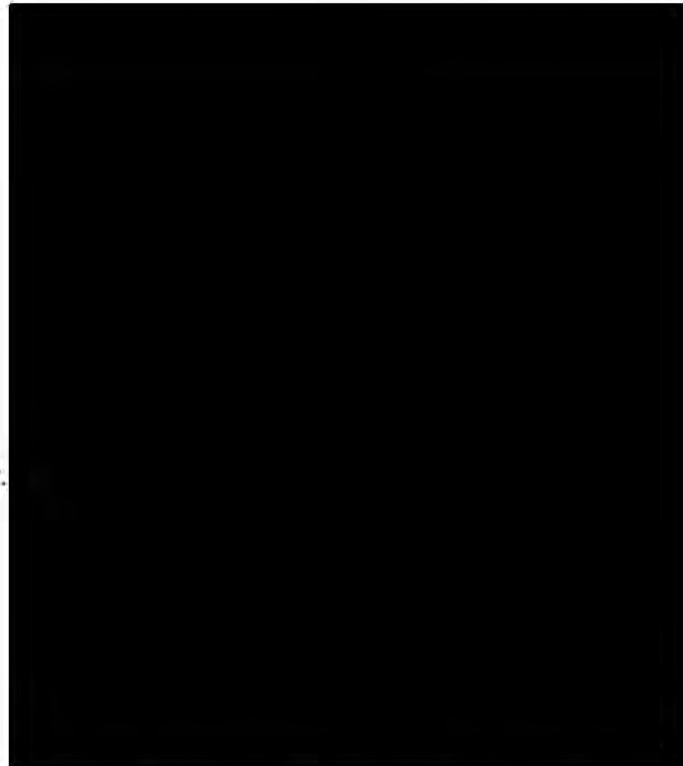
JOINT-RESOLUTION 10-02-86-02

A RESOLUTION DENYING THE ENROLLMENT INTO THE MILLE LACS BAND, MILLE LACS RESERVATION FOR THOSE WHO DO NOT MEET THE 1/4 DEGREE REQUIREMENTS OF THE MINNESOTA CHIPPEWA TRIBE.


