JOINT-RESOLUTION 10-01-30-02

A RESOLUTION APPROVING THE AGREEMENT BETWEEN STATE OF MINNESOTA AND THE MILLE LACS BAND OF OJIBWE FOR PURPOSES OF IMPLEMENTING PROVISIONS OF FEDERAL, STATE, AND TRIBAL LAW REGARDING UNEMPLOYMENT INSURANCE.

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Mille Lacs Band Assembly has the authority and duty to ratify agreements, contracts, cooperative and reciprocity agreements and memoranda of understanding; and

WHEREAS, the Chief Executive of the Mille Lacs Band has the power and duty to conduct external relations with all other governments and their political subdivisions; and

WHEREAS, the Chief Executive has the power and duty to recommend agreements, contracts, cooperative and reciprocity agreements and memoranda of understanding to the Band Assembly for ratification; and

WHEREAS, the Executive Branch of the Mille Lacs Band of Ojibwe has the power and duty to negotiate and execute agreements, contracts, cooperative and reciprocity agreements, memoranda of understanding, on behalf of the Band, subject to ratification by the Band Assembly.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly, in concurrence with the Chief Executive ratifies the Agreement between the State of Minnesota and the Mille Lacs Band of Ojibwe for purposes of implementing provisions of federal, state, and tribal law regarding unemployment insurance, and further authorizes the Executive Branch of Band government to execute such Agreement.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 30th day of January, 2002 at Onamia, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.


