**A RESOLUTION TO RESCIND LEASE AUTHORIZED BY  
RESOLUTION #04-02-32-91 FOR [REDACTED] &  
[REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #04-02-32-91, authorized a tribal land lease to be given to [REDACTED] for the purpose of establishing a home; and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective December 20, 1990, for the property described herein; and,

WHEREAS, said land is described as follows:

A part of Tract # 410 T33 described as follows:

Beginning at the Northeast corner of the Southeast Quarter of the Northeast Quarter, thence West 363 feet, thence South 278 feet to the point of beginning; thence West 200 feet; thence South 150 feet, thence East 200 feet, thence North 150 feet to the point of beginning, Section 28, Township 43 North, Range 27 West, Fourth Principal Meridian, Mille Lacs County, Minnesota; and,

WHEREAS, [REDACTED] have signed a document requesting rescinding of resolution #04-02-32-91 due to non-use and currently occupying the site immediately south and adjacent to this lease site.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the rescinding of the lease authorized by Band Resolution #04-02-32-90; and,

BE IT FURTHER RESOLVED, that the land will revert back to the Mille Lacs Band of Ojibwe.

RESOLUTION 04-02-32-91

A RESOLUTION GRANTING A LAND LEASE TO RAYMOND KEGG AND MARILYN DAVIS.

WHEREAS, Raymond Kegg and Marilyn Davis wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite; and,

WHEREAS, tribal land leases are needed from the tribal reservation for the purpose of repayment of home loans-Minnesota Chippewa Tribe Home Loan Program in case of a default; and

WHEREAS, said land is described as follows: Beginning at the Northeast corner of the SE 1/4 of the NE 1/4, thence West 363 feet, thence South 278 feet to the point of beginning; thence West 200 feet; thence South 150 feet; thence East 200 feet; thence North 150 feet to the point of beginning; Section 28, Township 43 North, Range 27 West; Mille Lacs County, Minnesota; which it is agreed shall be deemed personal property; and,


WHEREAS, the lease will have to be for a period of 25 years plus 25 years effective December 20, 1990 for the purpose of financing this home.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease be issued to Raymond Kegg and Marilyn Davis for a period of 25 years plus 25 years renewal effective December 20, 1990.


BE IT FURTHER & FINALLY RESOLVED, that leasee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, or if the leasee defaults on their home mortgage this lease will then revert back to the Mille Lacs Band of Chippewa Indians.
