JOINT-RESOLUTION 09-04-11-02

A RESOLUTION GRANTING TRANSFERS OF ENROLLMENT TO THE MILLE LACS BAND, MILLE LACS RESERVATION FROM LEECH LAKE RESERVATION OF THE MINNESOTA CHIPPEWA TRIBE.

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band Assembly screens all membership considerations and has reviewed the following applications for transfer from the Leech Lake Band to the Mille Lacs Band; and,


