**RESOLUTION 10-02-92-02**

**A RESOLUTION TO CANCEL LEASE AUTHORIZED BY RESOLUTION  
#01-82 FOR [REDACTED]**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,
- WHEREAS, Resolution #01-82, authorized a lease to be given to [REDACTED] for the purpose of obtaining a MCT home loan; and,
- WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective November 9, 1981, for the property described herein; and,
- WHEREAS, said land is described as follows:

Part of Tract # 410 T 1002:

Beginning at the Southwest corner of the north one-half of the northeast quarter, thence north 695.53, thence east 48.7 feet to the point of beginning, thence north 200 feet, thence east 100 feet, thence south 200 feet, thence west 100 feet to point of beginning in Section 28, Township 43 North, Range 27 West, Fourth Principal Meridian containing 1 acre more or less.

Also know as: Lot 3, Block 1, Vineland Hills Plat

- WHEREAS, [REDACTED] is deceased, DOD 4/15/95 and [REDACTED] is voluntarily canceling their lease due to non-use of the site.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Cancellation of the lease authorized by Band Resolution #01-82; and,

BE IT FURTHER RESOLVED, that the land will revert back to the Mille Lacs Band of Ojibwe for lease to another Band member.


