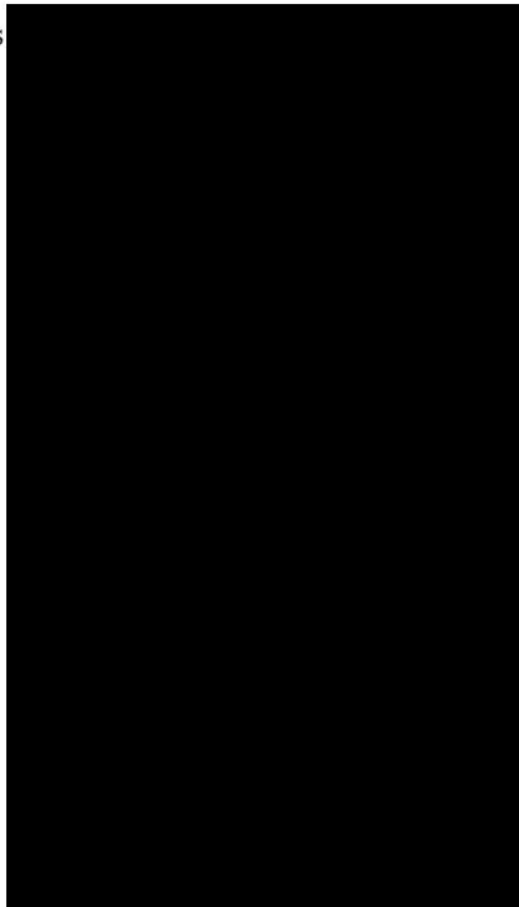
JOINT-RESOLUTION 09-04-04-02


