RESOLUTION 10-01-60-02

**A RESOLUTION TO RESCIND LEASE AUTHORIZED BY
RESOLUTION #06-03-101-95 FOR [REDACTED] ALSO
KNOWN AS [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #06-03-101-95, authorized a tribal land lease to be given to [REDACTED] [REDACTED] for the purpose of establishing a home; and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective May 11, 1995, for the property described herein; and,

WHEREAS, Resolution #06-03-101-95 stated that the lessee will utilize the provisions of the resolution within 12 months, if provisions are not met, lease will then revert back to the band; and,

WHEREAS, said land is described as follows:

That part of the NE ¼ of NW ¼ of Section 17, Spalding Township 47N, Range 23 W, Beginning at the Southeast corner of Lot 5, thence South 100 feet, thence West 170 feet, thence North 100 feet, thence East 170 feet to the point of beginning. Know as lot 6, according to the platted map of C..A. Hammond Plat July 24, 1969; and,

WHEREAS, [REDACTED] did not meet the terms of Resolution # 06-03-101-95 by not establishing a residence at the site described herein by May 11, 1996 (12 months after the effective date of the lease).

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the rescinding of the lease authorized by Band Resolution #06-03-101-96; and,


