RESOLUTION 10-02-70-02

A RESOLUTION TO RESCIND LEASE AUTHORIZED BY
RESOLUTION #02-02-03-88 FOR [REDACTED]

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #02-02-03-88, authorized a tribal land lease to be given to [REDACTED] for the purpose of establishing a home; and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective October 7, 1987, for the property described herein; and,

WHEREAS, said land is described as follows:

A part of Tract # 410 T33 described as follows:

Beginning at the Northeast corner of the Southeast Quarter of the Northeast Quarter, thence West 363 feet, thence South 218 feet, thence West 200 feet to the point of beginning; thence West 200 feet, thence South 60 feet, thence East 200 feet, thence North 60 feet to the point of beginning, Section 28, Township 43 North, Range 27 West, Fourth Principal Meridian, Mille Lacs County, Minnesota; and,

WHEREAS, [REDACTED] has signed a document requesting rescinding of resolution #02-02-03-88 due to non-use.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the rescinding of the lease authorized by Band Resolution #02-02-03-88; and,

BE IT FURTHER RESOLVED, that the land will revert back to the Mille Lacs Band of Ojibwe.
