**Resolution 10-01-64-02**

**A RESOLUTION APPROVING THE SUBMISSION OF A GRANT TO THE ADMINISTRATION FOR NATIVE AMERICANS FOR THE CONTINUED DEVELOPMENT OF THE LANGUAGE AND CULTURE CAMP.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Mille Lacs Band Assembly has established as a priority to improve the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and

WHEREAS, the Mille Lacs Band Assembly recognizes the importance of preserving and sharing the Ojibwe language, culture, and traditions of its people; and

WHEREAS, the Mille Lacs Band Assembly has created the Language and Cultural Immersion Grounds/Camp to provide language and cultural training for Band members, non-Band members, and non-Indians who have an interest in learning the history, language, culture, and traditions of the Ojibwe people of the Mille Lacs Reservation; and

WHEREAS, the Mille Lacs Band Assembly has a goal to pursue greater self-sufficiency through economic development and the continued education and training of all people, Indian and non-Indian within the greater community; and

WHEREAS, the Language and Cultural Immersion Grounds/Camp seeks to provide an Ojibwe Language and Cultural Education Program and Cultural Awareness Sensitivity Training for college and high school teachers, student teachers, secondary and elementary students, and the general public on a fee for service basis;

NOW THEREFORE BE IT RESOLVED that the Mille Lacs Band Assembly does hereby authorize and approve the submission of a Language and Cultural Economic Development grant to the Administration for Native Americans on behalf of the Mille Lacs Band of Ojibwe Language and Cultural Immersion Grounds/Camp.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 17<sup>th</sup> of May, 2002 at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
