RESOLUTION 10-03-36-03

A RESOLUTION ATTACHING A MORTGAGE TO A RESIDENTIAL LEASE FOR AUTHORIZED BY RESOLUTION #10-02-93-02

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,
- WHEREAS, Resolution #10-02-93-02 authorized a lease to be given to to the subject property for the purpose of establishing a home-site; and,
- WHEREAS, has applied to the Minnesota Chippewa Tribe Home Loan Program for financing for the construction of a home located on the subject property; and,
- WHEREAS, the lease needs to be modified to include the mortgage; and,
- WHEREAS, the lease will be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective December 13, 2002, for the property described herein:

Part of Tract 410 TF194 located in the West one-half (W ½) of the Southwest one-quarter (SW ¼) of Section Twenty-three (23), Township Forty-two North (T42N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows:

Commencing at a Global Positioning System (GPS) coordinate (444,316.21; 5,105,406.90 thence bearing North 42 degrees 6 minutes 44 seconds West a distance of 227.30 feet; thence North 40 degrees 54 minutes 52 seconds East a distance of 170.19 feet; thence South 51 degrees 18 minutes 6 seconds East a distance of 220.94 feet; thence South 39 degrees 34 minutes 7 seconds West a distance of 206.38 feet to GPS coordinate (444,316.21; 5,105,406.90), the point of

beginning (GPS coordinates are Universal Transverse Mercator (UTM) Zone 15 NAD 83 Projection Points). The leasesite is approximately 1 acre more or less.

- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes modification of the lease to the property described herein to include the mortgage issued to and all other terms and conditions shall remain the same and the only change will be to reflect the attachment of the mortgage; and,
- BE IT FURTHER RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1st year anniversary of the effective date of the lease without the prior approval of the Band Assembly; and,
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 18th of March, 2003 at Onamia, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
