**RESOLUTION 10-03-31-03**

**A RESOLUTION TO RESCIND LEASE AUTHORIZED BY  
RESOLUTION #05-02-65-92 FOR [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #05-02-65-92, authorized a lease to be given to [REDACTED] for the purpose of residential homesite; and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective July 16, 1992 for the property described herein; and,

WHEREAS, said land is described as follows:

All that part of Government Lot 2, Section 17, Township 43, Range 27, Mille Lacs County, Minnesota, described as follows:

Commencing at a found Brass Cap monument at the southeast corner of said Government Lot 2; thence North 89 degrees 55 minutes 10 seconds West, assumed bearing along the south line of said Government Lot 2, a distance of 751.97 feet; thence North 1 degree 51 minutes 57 seconds West a distance of 553.52 feet to a point on the southerly line of County State Aid Highway No. 35; thence North 88 degrees 08 minutes 03 seconds East, along said southerly line, a distance of 200.00 feet to the point of beginning of the lot to be described; thence continuing North 88 degrees 08 minutes 03 seconds East, along said southerly line, a distance of 100.00 feet; thence South 1 degree 51 minutes 57 seconds East a distance of 200.00 feet; thence south 88 degrees 08 minutes 03 seconds West a distance of 100.00 feet; thence North 1 degree 51 minutes 57 seconds West a distance of 200.00 feet to the point of beginning; and,



NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Rescinding of the lease authorized by Band Resolution #09-03-13-01; and,

BE IT FURTHER RESOLVED, that the land will revert back to the Mille Lacs Band of Ojibwe for lease to another Band member.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislatures being present held on the 27th of January, 2003 at Onamia, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
