RESOLUTION 10-02-13-03

**A RESOLUTION RESCINDING RESOLUTION #06-03-62-95
AUTHORIZING A RESIDENTIAL LAND LEASE TO MILLE LACS
RESERVATION HOUSING AUTHORITY.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and;

WHEREAS, Resolution #06-03-62-95, authorized a land lease for residential purposes to be given to MLRHA, and

WHEREAS, the residential lease was to be for a period of 25 years and renewable for an additional 25 years, and is subject to the lease provisions, effective upon date of approval; and,

WHEREAS, said land is described as follows:

Part of Tract 410 T 1002 located in the North One Half (N ½) of the Northeast one-quarter (NE ¼) of Section Twenty-eight (28), Township Forty-three North (T43 North), Range Twenty seven north (R27N), Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows:

Lot Three (3), Block one (1), Vineland Hills Plat dated March 9, 1982 by Anthony E. Kerrick registered surveyor # 12266.

WHEREAS, rescinding Resolution #06-03-62-95 is being requested due to existence of prior resolution which authorized a lease on this site to [REDACTED] making resolution #06-03-62-95 invalid.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Rescinding of Band Resolution #06-03-62-95; and,

BE IT FURTHER RESOLVED, that the land will revert back to the Mille Lacs Band of Ojibwe.


