**RESOLUTION 10-03-28-03**

**A RESOLUTION AUTHORIZING A RESIDENTIAL LAND LEASE TO  
THE MILLE LACS RESERVATION HOUSING AUTHORITY (MLRHA)  
FOR TEMPORARY TRANSITIONAL HOUSING**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, the Mille Lacs Reservation Housing Authority (MLRHA), respectfully requests a residential lease for the purpose of establishing trailer sites for temporary transitional housing for use by Mille Lacs Band members in Districts I, District II and District III; and,

WHEREAS, the lease will be for a period of 5 years, and renewable for an additional 5 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and,

WHEREAS, said land is described as follows:

Part of Tract #410 T 1002, located in the North one-half (N ½) of the Northeast one-quarter (NE ¼) of Section Twenty eight (28), Township Forty-three north (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows:

Lot Nine (9), Block Four (4), Vineland Hills Plat dated March 9, 1982, by Anthony E. Kerrick registered surveyor #12266.

WHEREAS, The lease rental is \$1.00 and there is a \$2.00 lease processing fee.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes a land lease on the property described herein to be issued to the MLRHA for the purpose of establishing a trailer site for temporary transitional housing for use by a Mille Lacs Band member, for a period of 2 years, subject to the lease provisions, effective upon date of approval; and,



BE IT FURTHER RESOLVED, that the lessee will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert back to the Mille Lacs Band of Ojibwe; and,

BE IT FURTHER RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1<sup>st</sup> year anniversary of the effective date of the lease without the prior approval of the Band Assembly.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 27<sup>th</sup>, of January, 2003 at Onamia, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
