**JOINT RESOLUTION 10-02-08-03**

**A RESOLUTION APPROVING THE ENROLLMENT INTO THE MILLE LACS BAND, MILLE LACS RESERVATION, DUE TO AN INCREASE IN BLOOD QUANTUM.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band Assembly screens all membership considerations and has reviewed the following application for enrollment; and,

WHEREAS, the Mille Lacs Band Assembly has reviewed the application to reconsider the blood quantum for Chaska Angeni Spears, dob: [REDACTED] establishing her blood quantum as [REDACTED] and,

WHEREAS, the resolution denying Chaska Angeni Spears enrollment is Resolution 09-04-05-02 dated October 16, 2001; and,

WHEREAS, the changes should be made on the records of the Minnesota Chippewa Tribe.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly approves the above application for enrollment and approves all rights provided for the Minnesota Chippewa Tribe enrollees.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 22<sup>nd</sup> day of October, 2002 at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
