RESOLUTION 10-03-57-03

A RESOLUTION AUTHORIZING THE MILLE LACS BAND COMMUNITY DEVELOPMENT DEPARTMENT TO DEVELOP PLANS AND CONSTRUCT HOUSING FOR MILLE LACS BAND MEMBERS

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, there is an urgent need for housing for Mille Lacs Band members such that the Department of Community Development has been appropriated funds to be used in the Housing Initiative Plan through Band Assembly Bill 09-03-13-01 to provide Band housing; and,
- WHEREAS, the provision of Band housing includes the cost of subdivision design, infrastructure design and construction, and environmental evaluation and assessment preparation in addition to housing construction costs, and
- WHEREAS, the Department of Community Development, respectfully requests permission to proceed with development of residential site plans, infrastructure design and construction, and building construction for sites targeted for new housing without a lease; and,
- WHEREAS, the Department of Community Development will only be allowed to proceed on those sites when the following requirements have been met:
 - 1. Approved Application
 - 2. Completed Survey
 - 3. Completed Environmental Assessment (EAW)
- WHEREAS, the Department of Community Development will use the followings sites described herein for development under the Housing initiative Plan; and
- WHEREAS, said land is described as follows:

District I (3 sites)

A part of Tract # 410 TF 158 located in the Southwest Quarter (SW 1/4) of the Southwest Quarter (SW 1/4) of Section Six (6), Township Forty-three North (T43N), Range Twenty-seven West (R27W), Fourth Principle Meridian, Mille Lacs County, Minnesota more particularly described as follows:

- WHEREAS, upon completion of the housing projects occurring on the sites listed above, a resolution and lease will be processed for the Mille Lacs Reservation Housing Authority to operate and maintain the homes utilizing MLRHA policies and procedures; and
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes the Community Development of the Mille Lacs Band to proceed with the development of residential site plans, infrastructure design and construction, and building construction for the sites mentioned above without a lease, upon completion of an approved application, completed survey and completed environmental assessment (EAW) for each site; and,
- NOW, THEREFORE, BE IT FURTHER RESOLVED, upon completion of the housing projects, a resolution and lease will be processed for the Mille Lacs Reservation Housing Authority to operate and maintain the homes utilizing MLRHA policies and procedures;
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of 3 legislators present held on the 13th of May, 2003 at Onamia, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
