RESOLUTION 10-04-69-03

**A RESOLUTION CANCELING A BUSINESS LAND LEASE FOR
[REDACTED] AUTHORIZED BY RESOLUTION
#08-01-99-98.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #08-01-99-98, authorized a business lease to [REDACTED] and,

WHEREAS, the lease was for a period of 10 years and renewable for an additional 10 years, subject to the lease provisions, effective May 19th 1998, for the property described herein; and,

WHEREAS, lease site is described as that part of the Southeast Quarter (SE 1/4) of the Southeast Quarter (SE 1/4) of section 17, Township 43 North, Range 27 West, Mille Lacs County, Minnesota, 4th principal meridian described as follows:

Commencing at the Southeast corner of said Section 17; thence North 1 degree 07 minutes 44 seconds West, assumed bearing, 788.90 feet along the East line of said Southeast Quarter of the Southeast Quarter, thence South 88 degrees 52 minutes 16 seconds West 533.20 feet to the southerly right of way line of State Highway No. 169, the point of beginning of said tract to be described; thence South 26 degrees 50 minutes 18 seconds West 500.00 feet; thence North 57 degrees 48 minutes 54 seconds West 284.49 feet; thence North 11 degrees 23 minutes 42 seconds West 500.00 feet to said southerly right of way line of State Highway No. 169; thence Southeasterly along said southerly right of way line of State Highway No. 169, along a curve to the right, having a radius of 2215.66 feet, a central angle of 15 degrees 30 minutes 56 seconds, and an arc length of 600.00 feet, to the point of beginning.

WHEREAS, [REDACTED] is relinquishing his leasesite and selling the improvements located within the leasesite to the Mille Lacs Band of Ojibwe.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the cancellation of the lease authorized by Band Resolution #08-01-99-98; and,

BE IT FURTHER AND FINALLY RESOLVED that the land described herein will revert back to the Mille Lacs Band of Ojibwe.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a of legislators being quorum present held on the 22nd of July, 2003 at Onamia, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
