**JOINT-RESOLUTION 11-01-29-04**

**A RESOLUTION APPROVING THE ENROLLMENT INTO THE MILLE LACS BAND, MILLE LACS RESERVATION, DUE TO AN INCREASE IN THEIR BLOOD QUANTUM.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Mille Lacs Band Assembly screens all membership considerations and has reviewed the following applications for enrollment; and

WHEREAS, the Mille Lacs Band Assembly has reviewed the attached documentation for [REDACTED] and find the increase to his blood quantum should be corrected from [REDACTED] and

WHEREAS, with this new documentation, [REDACTED] daughter [REDACTED] d.o.b. [REDACTED] will now be eligible for enrollment into the Mille Lacs Band, her blood quantum has increased from [REDACTED]


WHEREAS, the resolution denying [REDACTED] enrollment is Resolution 10-03-24-03 dated January 16, 2003; and

WHEREAS, the changes should be made on the records of the Minnesota Chippewa Tribe.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly approves the above applications for enrollment and approves all rights provided for the Minnesota Chippewa Tribe enrollees.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 20th day of January, 2004 at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.


