## JOINT RESOLUTION 11-01-54-04

### **A RESOLUTION APPROVING THE BLOOD QUANTUM INCREASE, BASED ON NEW ENROLLMENT ORDINANCE, SECTION VII. D.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the Minnesota Chippewa Tribal Executive Committee has adopted a new Enrollment Ordinance by Resolution No. 116-03, passed July 30, 2003 at a regular meeting of the Tribal Executive Committee; and,

WHEREAS, the Mille Lacs Band Assembly has reviewed the following documentations, and based on the new Enrollment Ordinance, section VII. D. the blood quantum of:

All of the above siblings have the same parents.


