RESOLUTION 11-01-67-04

**A RESOLUTION TO RESCIND RESOLUTION #11-01-44-04 WHICH
AUTHORIZED A LAND LEASE FOR [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #11-01-44-04, authorized a land lease to [REDACTED] for the purpose of a homesite; and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective March 23, 2004 for the property described herein; and,

WHEREAS, said land is described as follows:

Part of Tract 410 T 1002 located in the North one-half (N ½) of the Northeast One-quarter (NE ¼) of Section Twenty-eight (28), Township Forty-three North (T43N) Range Twenty-seven West (R27W) Mille Lacs County, Minnesota, Fourth Principal Meridian, more particularly described as follows:

Lot Eight (8), Block Four (4), Vineland Hills Plat dated March 9, 1992, by Anthony E. Kerrick registered surveyor #12266; and,


WHEREAS, [REDACTED] has been approved for financing from the Mille Lacs Band of Ojibwe Housing Department for the purpose of a home loan for a house located in the Bugg Hill Development; and,

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves rescinding Band Resolution #11-01-44-04 which authorized a lease to [REDACTED] at the property described herein; and,

BE IT FURTHER AND FINALLY RESOLVED that the land described herein will revert back to the Mille Lacs Band of Ojibwe for lease to another Band member.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 16th day of June, 2004 at Onamia, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
