RESOLUTION 11-02-15-05

A RESOLUTION AUTHORIZING A LAND LEASE FOR RESIDENTIAL PURPOSES TO THE MILLE LACS BAND HOUSING DEPARTMENT (MLBHD)

- the Mille Lacs Band Assembly is the duly-elected governing body of the Mille WHEREAS, Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe WHEREAS. for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- the Mille Lacs Band Housing Department respectfully requests a land lease for WHEREAS, Residential purposes; and
- the lease will be for a period of 25 years and renewable for an additional 25 years, WHEREAS. subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:

Part of Tract # 410 T 1001, located in the North One-Half (N ½) of the Northeast One-quarter (NE 1/4) of Section Twenty (20), Township Forty-three North (T43N), Range Twenty-seven West, (R 27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, more particularly described as follows:

Lot Forty-two (42), Lot Forty-nine (49), Lot Fifty (50) and Lot Fifty-three (53), Bugg Hill Plat.

Part of Tract # 410 T 1030, described as Government Lots Six (6) and Seven (7) of Section Eighteen (18), Township Forty-three North (T43N), Range Twentyseven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, more particularly described as follows:

Lot Six (6), "D" Street Plat.

Part of Tract # 410 TF 138, located in the Southeast Quarter of the Northeast Quarter (SE ¼ of NE ¼) of Section Four (4), Township Forty-one North (T41N), Range Seventeen West (R17W), Fourth Principal Meridian, Pine County, Minnesota, described as follows:

Lot Three (3), Block Four (4), Wilderness Estates 1st Addition.

WHEREAS, The lease rental is \$1.00 and there is a \$2.00 lease processing fee.

- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes land leases for the property described herein for residential purposes be issued to the Mille Lacs Band Housing Department for a period of 25 years, renewable for an additional 25 years subject to the lease provisions, effective upon date of approval; and
- BE IT FURTHER RESOLVED, that the lessee will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert back to the Mille Lacs Band of Ojibwe; and
- BE IT FURTHER RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1st year anniversary of the effective date of the lease without the prior approval of the Band Assembly; and
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 21st of October, 2004 at Hinckley, Minnesota by a vote of 3_FOR, 0_AGAINST,_0_SILENT.
- IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the signature of the Speaker of the Assembly to be affixed to this resolution.
