RESOLUTION 11-02-20-05

A RESOLUTION TO MODIFY THE LEGAL DESCRIPTION FOR RESOLUTION # 11-01-39-04 WHICH AUTHORIZED THE REALIGNMENT OF COUNTY STATE AID HIGHWAY 15 (C.S.A.H. 15) IN EXCHANGE FOR PINE COUNTY VACATING A PORTION OF THE EXISTING RIGHT OF WAY FOR C.S.A.H. 15 LOCATED ON TRACT #'S 410T1016, 410TF115 AND 410TFC214 ALL LOCATED WITHIN PINE COUNTY, MINNESOTA

the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band WHEREAS, of Ojibwe, a federally-recognized Indian Tribe; and

Resolution 11-01-39-04 authorized the Corporate Commission to develop and construct a WHEREAS. right-of way located on Mille Lacs Band of Ojibwe Indian Fee land which when completed will be conveyed to Pine County Highway Department in exchange for vacating the portion of C.S.A.H.15 which currently exists on Mille Lacs Band of Ojibwe Trust and Fee Lands; and

the legal description for the centerline of the Right-of-Way to be conveyed to Pine WHEREAS. County as part of the realignment of C.S.A.H. 15 has been modified to reflect a safer engineering design; and,

WHEREAS. the modified legal description for the Centerline of the new portion of Right-of-Way is described below; and

the Right-of-Way to be conveyed to Pine County is a proposed 100 foot wide C.S.A.H. WHEREAS, 15 Realignment over, under and across affecting tracts 410 TF 115 and 410 TFC 214 located in section Twenty-nine, Township Forty-one North, Range Twenty West (Section 29, T41N, R20W), located in the 4th Principal Meridian, Pine County, Minnesota; and

the centerline of the proposed 100-foot wide C.S.A.H. 15 Realignment should be WHEREAS. described as follows:

> Commencing at the northwest corner of the Northeast Quarter of Section 29, Township 41, Range 20, Pine County, Minnesota; thence on an assumed bearing of South 89 degrees 27 minutes 42 seconds East along the north line of said Northeast Quarter East a distance of 1084.31 feet to the point of beginning of said centerline; thence South 00 degrees 28 minutes 36 seconds West a distance of 147.09 feet; thence southerly 379.64 feet along a tangential curve concave westerly having a radius of 5000.00 feet and a central angle of 4 degrees 21 minutes 01 seconds; thence South 04 degrees 49 minutes 37 seconds West, tangent to said curve a distance of 220.83 feet; thence southerly 373.91 feet along a tangential curve concave easterly having a radius of 5000.00 feet and a central angle of 4 degrees 17 minutes 05 seconds; thence South 00 degrees 32 minutes 32 seconds West tangent to said curve a distance of 197.59 feet; thence southwesterly

927.10 feet on a tangential curve concave northwesterly having a radius of 800 feet and a central angle of 66 degrees 23 minutes 55 seconds; thence South 66 degrees 56 minutes 27 seconds West, tangent to said curve, a distance of 202.76 feet; thence westerly and southerly 604.47 feet along a tangential curve concave to the southeast having a radius of 510.00 feet and a central angle of 67 degrees 54 minutes 34 seconds to the west line of said Northeast Quarter; thence South 00 degrees 58 minutes 07 seconds East, tangent to said curve a distance of 30.52 feet along said west line to the southwest corner said Northeast Quarter and said centerline there terminating.

- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes modification of Resolution 11-01-39-04, modifying the legal description for the centerline of the proposed 100-foot wide C.S.A.H. 15 realignment described herein and all other terms and conditions in Resolution 11-01-39-04 shall remain the same and the only change will be to reflect the above modified description; and
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present on the 18th of November, 2004 at Hinckley, Minnesota by a vote of <u>2</u> FOR, <u>0</u> AGAINST, <u>0</u> SILENT.
