RESOLUTION 11-02-11-05

A RESOLUTION GRANTING TRANSFER OF ENROLLMENT TO THE MILLE LACS BAND, MILLE LACS RESERVATION FROM WHITE EARTH RESERVATION OF THE MINNESOTA CHIPPEWA TRIBE.

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band Assembly screens all membership considerations and has reviewed the following applications for transfer from the White Earth Band to the Mille Lacs Band; and,

WHEREAS, the following individual is eligible due to their ancestral background:

Sharon Lee Fox Haywood Pennock [REDACTED]

WHEREAS, our office is in support of the band transfer of Sharon Fox Haywood Pennock from the White Earth Reservation to the Mille Lacs Band of Ojibwe, and

WHEREAS, we have located Resolution 58-73, enrolling Jimmy Fox Jr. (full sibling of Sharon Fox) into the Mille Lacs Band, and

WHEREAS, we have also located Resolution 15-71, enrolling Sharon Fox into White Earth, and

WHEREAS, attached is a letter from a former RBC Committee member who verifies that the committee had neglected to transfer Sharon Fox Pennock as they did not recognize her married name, and


WHEREAS, this enrollment to the Mille Lacs Band of Ojibwe will become effective immediately upon relinquishment from the White Earth Reservation.

NOW THEREFORE, BE IT RESOLVED, included are copies of the 1941 Base Roll showing the parents of Sharon Fox, Birth Certificates, enrollment cards, and letters this family dating back to 1996.

NOW, THEREFORE, BE IT FINALLY RESOLVED, that the Mille Lacs Band Assembly accepts the above individual for enrollment and recommends that the Minnesota Chippewa Tribe and Bureau of Indian Affairs make the required transfer.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 19th day of October, 2004 at Lake Lena, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.

IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the signature of the Speaker of the Assembly to be affixed to this resolution and forwarded to the Chief Executive for Concurrence.
