## JOINT RESOLUTION 11-02-12-05

### **A JOINT RESOLUTION APPROVING THE BLOOD QUANTUM INCREASE, BASED ON NEW ENROLLMENT ORDINANCE, SECTION VII D**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Minnesota Chippewa Tribal Executive Committee has adopted a new Enrollment Ordinance by Resolution No. 116-03, passed July 30, 2003 at a regular meeting of the Tribal Executive Committee; and

WHEREAS, the Mille Lacs Band Assembly has reviewed the following documentations, and based on the new Enrollment Ordinance, section VII D the blood quantum of:

Dale Wesley Day (Ballinger), [REDACTED]; will be increased from [REDACTED] to [REDACTED]

WHEREAS, the attached is a copy of the birth certificate, and an affidavit from a sister of Jennie Day, and the base roll for Monroe James Ballanger, showing the blood quantum as [REDACTED] and

WHEREAS, Resolution 11-01-30-04 did not process Dale Wesley Day Ballinger's blood quantum with his sibling's is because the available birth certificate not listing his parent's information.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly approves the above individuals' blood quantum increase, based on the new Enrollment Ordinance, Section VII D.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 21st, day of October 2004 at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.




