RESOLUTION 11-03-50-05

A RESOLUTION MODIFYING RESOLUTION # 11-02-05-05 WHICH AUTHORIZED A LAND LEASE FOR RESIDENTIAL PURPOSES TO

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,
- WHEREAS, Resolution 11-02-05-05 authorized a land lease to [REDACTED] for the purpose of establishing a home site; and,
- WHEREAS, the lease is for a period of 35 years and renewable for an additional 15 years, subject to the lease provisions, effective upon date of approval for the property described herein; and,
- WHEREAS, [REDACTED] wishes to add her son [REDACTED] to the lease as co-lessee; and
- WHEREAS, said land is described as follows:

Part of Tract #410 T 1030, described as Government Lots Six (6) and Seven (7) of Section Eighteen (18), Township Forty-three North (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, more particularly described as follows:

Lot Two (2), "D" Street Plat.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes modification of Resolution 11-02-05-05 by adding [REDACTED] to the lease as co-lessee. All other terms and conditions shall remain the same.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 24th of February, 2005 at Isle, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.


