## JOINT RESOLUTION 11-02-14-05

### **A JOINT RESOLUTION APPROVING THE BLOOD QUANTUM INCREASE, BASED ON NEW ENROLLMENT ORDINANCE, SECTION VII. D.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe, and

WHEREAS, the Minnesota Chippewa Tribal Executive Committee has adopted a new Enrollment Ordinance by Resolution No. 116-03, passed July 30, 2003 at a regular meeting of the Tribal Executive Committee, and

WHEREAS, the Mille Lacs Band Assembly has reviewed the following documentations, and based on the new Enrollment Ordinance, section VII.D. the blood quantum of:


