RESOLUTION 11-05-106-05

A RESOLUTION TO RESCIND RESOLUTION 05-03-50-93 WHICH AUTHORIZED A LAND LEASE FOR [REDACTED]

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,
- WHEREAS, Resolution 05-03-50-93, authorized a land lease to [REDACTED] for the purpose of a homesite; and,
- WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective February 2, 1993 for the property described herein; and,
- WHEREAS, said land is described as follows:
- Section 32, Township 49 North, Range 23 West, in Aitkin County. Beginning at the NW corner of Lot 2, then 125 ft. West to NW corner of Lot 3, thence 200 ft. south to SW corner of Lot 3, thence 125 ft. East to SE corner of Lot 3, thence North 200ft. to point of beginning. All east and west line bearing are 88 degrees 46 minutes 5 seconds; and
- WHEREAS, [REDACTED] requests rescinding of Resolution 05-03-50-93 because she has been approved for financing from the Mille Lacs Band of Ojibwe Housing Department for the purpose of a home loan for a house located on a different site.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves rescinding Band Resolution 05-03-50-93 which authorized a lease to [REDACTED] at the property described herein; and,
- BE IT FURTHER AND FINALLY RESOLVED that the land described herein will revert to the Mille Lacs Band of Ojibwe for lease to another Band member.


