RESOLUTION 11-02-33-05

**A RESOLUTION TO RESCIND RESOLUTION #11-02-95-04 WHICH
AUTHORIZED A LAND LEASE FOR [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution 11-02-95-04, authorized a land lease to [REDACTED] for the purpose of a homesite; and,

WHEREAS, the lease was for a period of 35 years and renewable for an additional 15 years, subject to the lease provisions, effective August 3, 2004 for the property described herein; and,

WHEREAS, said land is described as follows:

Part of Tract # 410 T 1030, described as Government Lots Six (6) and Seven (7) of Section Eighteen (18), Township Forty-three North (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, more particularly described as follows:

Lot Two (2), "D" Street Plat.

WHEREAS, [REDACTED] has been approved for financing from the Mille Lacs Band of Ojibwe Indians Housing Department for the purpose of a home located on the lease description above; and,

WHEREAS, [REDACTED] no longer wishes to lease Lot Two (2) of "D" Street Plat; and,

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves rescinding Band Resolution 11-02-95-04 which authorized a lease with an attached mortgage to Penny Sue Hill at the property described herein; and,

BE IT FURTHER AND FINALLY RESOLVED that the land described herein will revert back to the Mille Lacs Band of Ojibwe for lease to another Band member.
