**JOINT RESOLUTION 11-04-25-06**

**JOINT CONTINUING RESOLUTION SUPPORTING PREDATORY  
OFFENDER REGISTRATION FOR AN INTERIM PERIOD**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body for the Mille Lacs Band of Ojibwe, a federally recognized Indian tribe; and

WHEREAS, the Chief Executive of the Band is empowered to exercise the executive branch powers of the Band; and

WHEREAS, 3 MLBSA § 2(a) authorizes the Band Assembly to enact laws which promote the general welfare of the people; and

WHEREAS, the Band Assembly recognizes that Band members deserve protection from predatory offenders who may reside on the Mille Lacs reservation; and

WHEREAS, the Mille Lacs Band of Ojibwe currently does not have a predatory offender registration law in place; and

WHEREAS, the Minnesota Court of Appeals held in State v. Jones, 700 N.W. 2d 556 (2005), that the state lacked subject matter jurisdiction to enforce the predatory offender registration law against tribal members living on the reservation; and The Jones case is currently under review with the Minnesota Supreme Court and

WHEREAS, the Mille Lacs Band Assembly is currently in the process of drafting an ordinance requiring predatory offenders living on the reservation to register and provide address notification to the Band's law enforcement authorities; and

WHEREAS, the Band Assembly supports adopting the Minnesota predatory offender registration requirements for an additional interim period or until the Band Statute is completed, whichever may occur first, for no longer than February 28, 2006.

NOW THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby adopts the State of Minnesota's predatory offender registration statute (Minn. Stat. §§ 243.166, and 243.167), for an additional interim period or until the Band Assembly adopts a Band predatory offender registration law, for no longer than February 28, 2006.




