RESOLUTION 12-01-71-06

A RESOLUTION TO CANCEL LAND USE AGREEMENT AUTHORIZED BY RESOLUTIONS # 07-04-107-97, # 08-03-41-99 & # 09-03-30-01 FOR [REDACTED]

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolutions # 07-04-107-97, # 08-03-41-99 & # 09-03-30-01 authorized a residential land lease to be given to [REDACTED] for the purpose of establishing her home and attaching a mortgage; and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and,

WHEREAS, said land is described as follows:

Tract D of Survey Job #955872, dated 9/22/95, and Registered in Book 16F, Page 72, Comstock and Davis, Inc.

That part of the Southwest Quarter of Section One (1), Township Forty-two (42) North, Range Twenty-five (25) West, Fourth Principal Meridian, Mille Lacs County, Minnesota, part of Tract 410 TF 93 described as follows: Commencing at the northeast corner of the West One-Half (W¹/₂) of the Northeast One-Quarter (NE¹/₄) of the southwest Quarter of Said Section One (1): thence North 88 degrees 38 minutes 44 seconds West, assumed bearing, along the north line of said Southwest Quarter 600.00 feet to the point of beginning of the tract of land to be described; thence continuing North 88 degrees 38 minutes 44 seconds West along the north line of said southwest Quarter 150.00 feet; thence South 01 degrees 21 minutes 16 seconds West 450.00 feet; thence South 88 degrees 38 minutes 44 seconds East 150.00 feet to an intersection with a line which bears South 01 degrees 21 minutes 16 seconds West from the point of beginning; thence North 01 degrees 21 minutes 16 seconds East 450.00 feet to the point of beginning.


WHEREAS, [REDACTED] has agreed to vacate her lease for a new location so that Community Development may use the property to develop for additional housing in District IIa.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Cancellation of the lease authorized by Band Resolutions # 07-04-107-97, # 08-03-41-99 & # 09-03-30-01; and,

BE IT FURTHER AND FINALLY RESOLVED, that the land will revert to the Mille Lacs Band of Ojibwe for development of Housing to lease to other Band members.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 23rd of February, 2006 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
