JOINT RESOLUTION 11-04-55-06

A JOINT RESOLUTION APPROVING THE BLOOD QUANTUM INCREASE, BASED ON NEW ENROLLMENT ORDINANCE, SECTION VIII. B.

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe, and

WHEREAS, the Minnesota Chippewa Tribal Executive Committee has adopted a new Enrollment Ordinance by Resolution No. 116-03, passed July 30, 2003 at a regular meeting of the Tribal Executive Committee, and

WHEREAS, the Mille Lacs Band Assembly has reviewed the following documentations, and

WHEREAS, based on the new Enrollment Ordinance, section VIII.B. the blood quantum of: Maude Mitchell Kegg, a.k.a. Now-ah-cumig-o-quay born [REDACTED] blood quantum should increase from [REDACTED] and


WHEREAS, research has been done investigating the blood quantum of this family and considerable evidence has shown that the mother of Maude Mitchell Kegg, Nancy Pine [REDACTED] a/k/a Ah-gwah-daush-ee is a full blood, and

WHEREAS, copies of Charlie Mitchell's enrollment card listing him as [REDACTED] family sheets, annuity rolls from 1898 that identify the family unit, a probate from Nancy Pine, copies of the 1941 Base Roll, copies of the 1910 Blood Roll and a family tree.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly approves the above individual blood quantum increase, based on the new Enrollment Ordinance, Section VIII.B.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 5th, day of January, 2006 at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.


