RESOLUTION 12-02-149-06

A RESOLUTION CANCELLING A LEASE AUTHORIZED BY RESOLUTION # 10-04-75-03 FOR A LAND LEASE TO [REDACTED]

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution #10-04-75-03 authorized a lease to be given to [REDACTED]; and

WHEREAS, the lease was for a period of 25 years plus 25 years renewal, subject to the lease provisions, effective upon September 11, 2003, for the property described herein; and

WHEREAS, said land is described as follows:

That part of Tracts #410 T 102 and #410 T 101 of Section Seventeen (17), Township Forty-Three North (T43N), Range Twenty-Seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota more particularly described as follows:

The point of beginning, Global Positioning System (GPS) Coordinate (439321.18; 5116653.48) thence on an assumed bearing north 89 degrees 49 minutes 19 seconds west a distance of 175.14 feet, thence north 0 degrees 32 minutes 58 seconds west a distance of 226.82 feet, thence south 89 degrees 28 minutes 51 seconds east, thence south 0 degrees 41 minutes 25 seconds west a distance of 225.74 feet to GPS coordinate (439321.18; 5116653.48), the point of beginning (GPS coordinates are Universal Transverse Mercator (UTM) Zone 15 NAD 83 Projection Points) the lease site is approximately 1 acre more or less.


WHEREAS, a cancellation of the lease was authorized by Resolution #10-04-75-03 [REDACTED] is being requested by Lessor due to non-use and to request for a new lease site; and

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Cancellation of the lease authorized by Band Resolution #10-04-75-03; and

BE IT FURTHER RESOLVED, that the land will revert back to the Mille Lacs Band of Ojibwe.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 2nd of August, 2006 at Tower, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
