RESOLUTION 11-04-59-06

**A RESOLUTION ESTABLISHING THE MILLE LACS BAND OF
OJIBWE DEPARTMENT OF ATHLETIC REGULATIONS**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly is authorized under 3 MLBSA § 2 to regulate the internal and external affairs of the Mille Lacs Bands in order to promote the general welfare of the people; and
- WHEREAS, the Mille Lacs Band of Ojibwe has a commitment in providing a venue to promote, establish, and enforce standards for the conduct of athletic events held on the Mille Lacs Band Reservation; and
- WHEREAS, the Mille Lacs Band of Ojibwe has civil jurisdiction pursuant to its inherent sovereignty to oversee and regulate all aspects regarding the conduct of competitive athletic events and to provide for the integrity of such events and the health and safety of the participants and spectators of such events within the boundaries of the Mille Lacs Band Reservation; and
- WHEREAS, competitive athletic events are valued on the Reservation as forms of entertainment, and revenue production; and
- WHEREAS, the Mille Lacs Band Assembly has determined that it is in the best interest of the Band to establish and enforce standards for the conduct of athletic events held on the Mille Lacs Reservation.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby establishes the intention to create, support, and maintain a Mille Lacs Band Department of Athletic Regulations; and
- BE IT FURTHER RESOLVED, that the Mille Lacs Band Assembly will draft and implement regulation rules professional boxing, mixed martial arts, and unarmed combat competitions.


