JOINT RESOLUTION 11-04-04-06

A JOINT RESOLUTION DENYING THE ENROLLMENT INTO THE MILLE LACS BAND, MILLE LACS RESERVATION FOR THOSE WHO DO NOT MEET THE 1/4 DEGREE REQUIREMENTS OF THE MINNESOTA CHIPPEWA TRIBE.

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band Assembly has reviewed the following applications for enrollment; and,

WHEREAS, the Mille Lacs Band Assembly has reviewed Article II-Membership of the Revised Constitution and By-laws of the Minnesota Chippewa Tribe.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly denies the above applications for enrollment because of failure to comply with requirements found in Article II of the Minnesota Chippewa Tribal Constitution.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 11th, day of October, 2005 at Hinckley, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.




