**A JOINT RESOLUTION IN SUPPORT OF THE APPOINTMENT OF
STEPHEN J. LUZAR TO THE MINNESOTA INDIAN MENTAL HEALTH
ADVISORY COUNCIL.**

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe; and,

WHEREAS, the Minnesota Indian Mental Health Advisory Council requires a resolution from the Mille Lacs Tribal government supporting the appointment of their Tribal representative to the Council,

WHEREAS, the Band Assembly recognizes the need to have representation on the American Indian Mental Health Advisory Council; and,

WHEREAS, Steve Luzar is employed as the Mental Health Therapist for the Mille Lacs Band of Ojibwe; and

WHEREAS the Band Assembly does hereby name Mr. Stephen J. Luzar as the representative for the Mille Lacs Band of Ojibwe to attend and participate in all American Indian Mental Health Advisory Council meetings on behalf on the Mille Lacs Band of Ojibwe; and

WHEREAS, all material or information obtained at these meetings shall be completely and factually distributed to all necessary programs and department heads as it pertains to Mental Health, Chemical Dependency, and Social Services programs within the Mille Lacs Band of Ojibwe and to comply with all necessary reporting requirements.

NOW THEREFORE, LET IT BE RESOLVED, that the Mille Lacs Band of Ojibwe wholeheartedly supports and endorses Steve Luzar as a member of the Minnesota Indian Mental Health Advisory Council.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 19th day of December, 2005 at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.


