**RESOLUTION 11-04-23-06**

**A RESOLUTION TO MODIFY RESOLUTION #83-33 WHICH  
AUTHORIZED LAND LEASES FOR MILLE LACS RESERVATION  
HOUSING AUTHORITY**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,
- WHEREAS, Resolution #83-33, authorized a land lease to the Mille Lacs Reservation Housing Authority for the purpose of homesites; and,
- WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective August 8, 1983 for the property described herein;
- WHEREAS, said land is described as follows:
- Part of Tract # 410 T 1013
- Onamia site 1, Govt. Lot 4, Sec. 31 T. 42N, R26W., District 2, Site 2, NE ¼ SW ¼ Sec. 21 T47N, R23W. District 2, Site 2A NE ¼ SW ¼ Sec 21 T47N, R23W, District 2 Site 3, SW ¼ SW ¼, Sec 22, T50N, R23W, District 2, Site 4, SW ¼ SW ¼, Sec 22, T50N, R23W
- WHEREAS, Removal of the following land description is requested from Resolution #83-33:
- District 2, Site 2, NE ¼ SW ¼, Section 21, Township 47 North, Range 23 West
- WHEREAS, the above lease description was subleased to Marvin Bruneau #410B5925 under Mutual Help and Occupancy Agreements (HUD) with the Mille Reservation Housing Authority now known as the Mille Lacs Band Housing Department; and,
- WHEREAS, Marvin Bruneau #410B5925 has satisfied his mortgage with the Mille Lacs Band of Ojibwe Housing Department and the lease description listed above should be removed from Resolution #83-33.


