RESOLUTION 12-02-152-06

A RESOLUTION TO RESCIND RESOLUTION #12-02-137-06 WHICH AUTHORIZED A LAND LEASE ASSIGNMENT FOR MILLE LACS BAND HOUSING DEPARTMENT (MLBHD).

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution #12-02-137-06, authorized a land lease assignment to the MLBHD for the purpose of a homesite; and
- WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective June 16, 2004 for the property described herein; and
- WHEREAS, the MLBHD requests rescinding resolution #12-02-137-06, because housing has found a buyer for the home through the Housing Initiative Home Loan Program; and
- WHEREAS, said land is described as follows:

Part of Tract # 410 T 1030, described as Government Lots Six (6) and Seven (7) of Section Eighteen (18), Township Forty three North (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, more particularly described as follows: Lot Three (3), "D" Street Plat.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves rescinding Band Resolution #12-02-137-06 which authorized a lease to MLBHD at the property described herein; and

BE IT FURTHER AND FINALLY RESOLVED that the land described herein will revert to the Mille Lacs Band of Ojibwe for lease to another Band member.


