**A JOINT RESOLUTION IN SUPPORT OF ENTERING INTO
MEMORANDUMS OF UNDERSTANDING (MOU) BETWEEN THE
DEPARTMENT OF ADMINISTRATION AND THE
DEPARTMENTS OF HEALTH AND HUMAN SERVICES,
EDUCATION AND TRIBAL POLICE**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the Band recognizes the need to extend and strengthen the chemical dependency and mental health related services to eligible Band Members and their first generation descendants who are receiving Temporary Assistance for Needy Families (TANF); as well as provide cultural activities including but not limited to Ojibwe language classes and scholarship services, to these same eligible Band Members, and,

WHEREAS, the Band approves of the Department of Administration entering into a Memorandum of Understanding for TANF recipients with the Department of Health and Human Services, and,

WHEREAS, The Band approves of the Department of Administration entering into a Memorandum of Understanding for TANF recipients with the Department of Education, and,

WHEREAS, The Band approves of the Department of Administration entering into a Memorandum of Understanding for TANF recipients with the Tribal Police Department.

WHEREAS, the MOU's identify the roles and responsibilities between the Mille Lacs Band Department of Administration, Department of Health and Human Services, Department of Education, and the Tribal Police Department.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby supports the three above mentioned Memorandum of Understandings between the Department of Administration and the Departments of Health and Human Services, Education and Tribal Police.


