JOINT RESOLUTION 12-02-135-06

A RESOLUTION REQUESTING THAT THE BUREAU OF INDIAN AFFAIRS PLACE LAND IN TRUST FOR THE MILLE LACS BAND OF OJIBWE INDIANS.

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band of Ojibwe have acquired lands, some within the exterior boundaries of the Mille Lacs Reservation for housing, agricultural and public purposes; and,

WHEREAS, The Mille Lacs Band of Ojibwe wishes to have these lands transferred to the United States of America in Trust for the Mille Lacs Band of Ojibwe Indians.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band of Ojibwe is hereby requesting the Bureau of Indian Affairs to accept the following land totaling approximately 473.9 acres to be transferred to the United States of America in Trust for the Mille Lacs Band of Ojibwe Indians;

Tract # 410 TF 193, described as follows:

Real Property located in the East one-half of the Northwest one-quarter (E ½ NW ¼), the North one-half of the Southeast one-quarter (N ½ SE ¼), and the Northeast one-quarter (NE ¼), all in Section Nineteen (19), Township Forty-three North (T43N), Range Twenty-seven West (R27W), except the North 650.00 feet of the East 403.0 feet of the Northeast one-quarter (NE ¼), of Section Nineteen (19), Township forty-three North (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota approximately 313.9 acres more or less; and,

Tract # 410 TF 179, described as follows:

Real Property located in the South one-half of the Southeast one-quarter (S ½ SE ¼), of Section Nineteen (19), Township Forty-three North (T43N), Range Twenty-seven West (R27W), lying south and east of the center line of County State Aid Road No. 25, Fourth Principal Meridian, Mille Lacs County, Minnesota, approximately 70 acres more or less; and,

Tract # 410 TF 86, described as follows:


Real Property located in the South one-half of the Southeast one-quarter (S ½ SE ¼), of Section Nineteen (19), Township Forty-three North (T43N), Range Twenty-seven West (R27W), except that part lying south and east of County State Aid Road No. 25, Fourth Principal Meridian, Mille Lacs County, Minnesota, approximately 10 acres more or less and,

Tract #410 TF 53, described as follows:

Real Property located in the South one-half of the Southwest one-quarter (S ½ SW ¼) of Section Twenty (20), Township Forty-three North (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, approximately 80 acres more or less.


