RESOLUTION 12-03-42-07

A RESOLUTION CANCELLING A LEASE AUTHORIZED BY A RESOLUTION FOR A LAND LEASE TO [REDACTED]

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, A Resolution, which is attached and therefore made apart of this resolution, authorized a lease to be given to [REDACTED]; and
- WHEREAS, the lease was for a period of 25 years plus 25 years renewal, subject to the lease provisions, effective upon March 02, 1979, for the property described herein; and
- WHEREAS, said land is described as follows:
- Part of Tract #410 TF 178, located in Section One (1), Township Forty-two North (T42N), Range Twenty-five West (R25W), Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows:
- Tract Three (3), of Comstock and Davis Survey Job number 950556.003; and
- WHEREAS, a Cancellation of Land Use Agreement for the lease authorized by the attached Resolution to [REDACTED] is being requested by Lessor due to non-use; and
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Cancellation of Land Use Agreement for the lease authorized by the attached Resolution; and
- BE IT FURTHER RESOLVED, that the land will revert to the Mille Lacs Band of Ojibwe.


