**RESOLUTION # 12-03-79-07**

**A RESOLUTION TO CANCEL LEASE AUTHORIZED BY RESOLUTION  
#05-03-77-93 & 81-1 FOR [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #05-03-77-93 & 81-1, authorized a lease to be given to [REDACTED] for the purpose of obtaining a leasesite; and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and,

WHEREAS, said land is described as follows:

Part of Tract 410 T 1002 located in Section Twenty-eight (28), Township Forty-three North (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota.

More particularly described as Follows: Block One (1), Lot Sixteen (16), Vineland Hills, Kathio Township. This lease site is 1 acre more or less.

WHEREAS, [REDACTED] is deceased (date of death November 25, 1998).

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Cancellation of the lease authorized by Band Resolution #05-03-77-93 & 81-1; and,


BE IT FURTHER RESOLVED, that the land will revert to the Mille Lacs Band of Ojibwe for lease to another Band member.
