JOINT RESOLUTION 12-03-54-07

A JOINT RESOLUTION APPROVING THE BLOOD QUANTUM INCREASE, BASED ON NEW ENROLLMENT ORDINANCE, SECTION VIII. B.

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe, and
- WHEREAS, the Minnesota Chippewa Tribal Executive Committee has adopted a new Enrollment Ordinance by Resolution No. 116-03, passed July 30, 2003 at a regular meeting of the Tribal Executive Committee, and
- WHEREAS, the Mille Lacs Band Assembly has passed Joint Resolution 12-03-34-07 on January 16, 2007 for the Matrious family, and
- WHEREAS, Carole Anne Matrious (Higgins) was erroneously not included in this Joint Resolution 12-03-34-07, and
- WHEREAS, in accordance with Enrollment Ordinance VIII.B. the Blood quantum of:




