## **RESOLUTION 12-02-21-07**

A RESOLUTION AUTHORIZING A LAND LEASE FOR RESIDENTIAL PURPOSES TO MILLE LACS BAND HOUSING DEPARTMENT (MLBHD)

- the Mille Lacs Band Assembly is the duly-elected governing body of the Mille WHEREAS. Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe WHEREAS. for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home;
- the Mille Lacs Band housing Department respectfully requests a land lease for a WHEREAS, Four-plex for Residential purposes; and
- WHEREAS, the lease will be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- said land is described as follows: WHEREAS.

Part of Tract 410 T 205, located in the North one half of the Northeast one quarter of the Southeast one quarter of the Northwest one quarter and the North one half of the South one half of the Northeast one quarter of the Southeast one quarter of the Northwest one quarter (N1/2NE1/4SE1/4NW1/4 and N1/2S1/2NE1/4SE1/4NW1/4) of Section Three (3), Township Forty-one North (T41N), Range Seventeen West (R17W), Fourth Principal Meridian, Pine County, Minnesota; and

Part of Tract 410 T 207, located in the South one half of the South one half of the Northeast one quarter of the Southeast one quarter of the Northwest one quarter and the North one half of the Southeast one quarter of the Southeast one quarter of the Northwest one quarter (S1/2S1/2NE1/4SE1/4NW1/4 and N1/2SE1/4SE1/4NW1/4) of Section Three (3), Township Forty-one North (T41N), Range Seventeen West (R17W), Fourth Principal Meridian, Pine County, Minnesota;

More particularly described as Follow: Commencing at a Global Positioning System (GPS) coordinate (540,299.81;5,101,373.91) thence bearing North 52 degrees 47 minutes 31 seconds West a distance of358.98 feet; thence North 34 degrees 42 minutes 59 seconds East a distance of 300.59 feet; thence South 53 degrees 01 minutes 11 seconds East a distance of 366.74 feet; thence South 36 degrees 11 minutes 59 seconds West a distance of 301.81 feet to GPS Coordinate (540,299.81;5,101373.91), to the point of beginning (GPS Coordinates are Universal Tranverse Mercator (UTM) Zone 15 NAD 83 Projection Points). The lease site is approximately 1 acre more or less.

- WHEREAS, The lease rental is \$1.00 and there is a \$2.00 lease processing fee.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes a land lease for the property described herein for residential purposes be issued to the Mille Lacs Band Housing Department for a period of 25 years, renewable for an additional 25 years subject to the lease provisions, effective upon date of approval; and
- BE IT FURTHER RESOLVED, that the lessee will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert to the Mille Lacs Band of Ojibwe; and
- BE IT FURTHER RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1<sup>st</sup> year anniversary of the effective date of the lease without the prior approval of the Band Assembly; and
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 21<sup>st</sup> of November, 2006 at Hinckley, Minnesota by a vote of \_3 FOR, \_OAGAINST, OSILENT.
