JOINT RESOLUTION 12-04-91-07

A JOINT RESOLUTION APPROVING THE BLOOD QUANTUM INCREASE, BASED ON NEW ENROLLMENT ORDINANCE, SECTION VIII. B.

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe, and
- WHEREAS, the Minnesota Chippewa Tribal Executive Committee has adopted a new Enrollment Ordinance by Resolution No. 116-03, passed July 30, 2003 at a regular meeting of the Tribal Executive Committee, and
- WHEREAS, the Mille Lacs Band Assembly has reviewed the following documentations, and
- WHEREAS, based on the new Enrollment Ordinance Section VIII.B, the blood quantum of Julia Gahbow Sam enrollment number [REDACTED] d/o/d 3/26/1978 will increase from [REDACTED] and
- WHEREAS, her sibling (Kay kin ah wah se kung a/k/a Sam Peet (Pete) having a blood quantum of [REDACTED] on the 1910 Blood Roll; and
- WHEREAS, her father Sam Peet (Pete) a/k/a Pedwaywaygeshig was on the 1910 Blood Roll however he died in 1909 therefore was not on the 1941 Base Roll; and
- WHEREAS, Julia's mother Akokwance is listed as [REDACTED] on the 1941 Base Roll; and
- WHEREAS, included are Enrollment cards, copies of the 1910 Blood Roll, copies of the 1941 Base Roll, copies of Allotment records, family sheets, family trees, and annuity records. This family is part of an appeals case from the Enrollment Review Committee.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly approves the above individual's blood quantum increase, based on the new Enrollment Ordinance, Section VIII.B.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 24th day of July, 2007 at Hinckley, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.




