RESOLUTION 12-04-142-08

A RESOLUTION AUTHORIZING A LAND LEASE FOR RESIDENTIAL **PURPOSES TO**

the Mille Lacs Band Assembly is the duly-elected governing body of the Mille WHEREAS, Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS. respectfully requests a land lease for Residential purposes; and

WHEREAS. the lease will be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS. said land is described as follows:

> Tracts Four (4) and Five (5) located within Tract # 410 T 1015, Central Minnesota Surveying, Inc., Job # 995909, dated August 18, 1999, Book Number Forty-one (41), Page Number Thirty-six (36).

> That part of the Southwest One-quarter (SW 1/4) of the Southwest One-quarter (SW 1/4) of Section Twenty-two (22), Township Fifty (50) North, Range Twentythree (23) West, Fourth Principal Meridian, Aitkin County, Minnesota, described as follows:

> Commencing at the Southwest (SW) corner of said Section Twenty-two (22); thence North Zero (00) degrees Thirty-seven (37) minutes Twenty-eight (28) seconds East, assumed bearing, along the west line of said Section Twenty-two (22) a distance of 80.39 feet; thence North Thirty-two (32) degrees Twenty-eight (28) minutes Twenty (20) seconds East 1157.17 feet along the existing centerline of Aitkin County Highway Number Thirty-six (36), formerly Aitkin County Highway Number Fourteen (14); thence South Fifty-seven (57) degrees Forty-one (41) minutes Forty (40) seconds East 33.00 feet to the easterly right of way line of said Aitkin County Highway Number Thirty-six (36), the point of beginning of the tract of land to be described; thence continuing South Fifty-seven (57) degrees Forty-one (41) minutes Forty (40) seconds East 200.00 feet to said easterly right of way line; thence North Thirty-two (32) degrees Eighteen (18) minutes Twenty

- (20) seconds East 200.00 feet along said right of way line to the point of beginning.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes a land lease for the property described herein for residential purposes be issued to for a period of 25 years, renewable for an additional 25 years subject to the lease provisions, effective upon date of approval; and
- BE IT FURTHER RESOLVED, that the lessee will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert to the Mille Lacs Band of Ojibwe; and
- BE IT FURTHER RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1st year anniversary of the effective date of the lease without the prior approval of the Band Assembly; and
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 17th of January, 2008 at Hinckley, Minnesota by a vote of <u>0</u> FOR, <u>3</u> AGAINST, <u>0</u> SILENT.
