**RESOLUTION 12-04-117-08**

**A RESOLUTION APPROVING THE TEMPORARY WAIVER OF BONDING REQUIREMENTS FOR CONSTRUCTION CONTRACTS AWARDED TO BAND MEMBER CONTRACTORS ON RESIDENTIAL CONSTRUCTION PROJECTS.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Mille Lacs Band Assembly acting pursuant to 3 MLBSA section 2 has the authority to enact laws which promote the general welfare of the Mille Lacs Band of Ojibwe; and

WHEREAS, the current bonding requirements set forth in Band Assembly Ordinance 03-06 would require bonding for Band-funded residential construction projects over \$50,000.00; and

WHEREAS, the current bonding requirements may be prohibitive for some Band member contractors to be awarded these projects; and

WHEREAS, the waiver of this requirement for contracts awarded to Band member contractors for Band-funded residential construction projects will enable more Band member contractors to complete these projects; and

WHEREAS, all necessary lien waivers would still be required; and

WHEREAS, the Band Assembly reserves the right to terminate this waiver at any time.

NOW THEREFORE BE IT RESOLVED, that bonding requirements set forth in Band Assembly Ordinance 03-06 are hereby temporarily waived for construction contracts awarded to Band member contractors for Band-funded, residential construction projects; and

BE IT FURTHER RESOLVED, that this temporary waiver applies only to contracts awarded to Band member contractors for the Band-funded residential construction projects and no other contracts; and

BE IT FURTHER RESOLVED, that all necessary lien waivers are still required and that the Band Assembly hereby reserves the right to terminate this waiver at any time without notice.


