RESOLUTION 13-02-72-08

**A RESOLUTION RESCINDING RESOLUTION # 12-03-65-07
AUTHORIZING A RESIDENTIAL LAND LEASE WITH AN ATTACHED
MORTGAGE TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and

WHEREAS, Resolution #12-03-65-07, authorized a land lease for residential purposes to be given to [REDACTED] for establishing his home with financing obtained from the Mille Lacs Band of Ojibwe Housing Department; and

WHEREAS, the residential lease was to be for a period of 35 years and renewable for an additional 15 years, and is subject to the lease provisions, effective May 22, 2007; and

WHEREAS, said land is described as follows:

A part of tract # 410 TF 11 located in Section Eight (8), Township Forty-three North, (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows:

Lots 128 and 129, Port Mille Lacs Plat. This lease site is 1 acre more or less.

WHEREAS, rescinding Resolution #12-03-65-07 is being requested by the lessee due to none use; and

WHEREAS, a document sent by the Lessee requesting rescinding Resolution # 12-03-65-07 is attached as exhibit A as a part of this resolution; and

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Rescinding of Band Resolution #12-03-65-07; and


