## **RESOLUTION 12-04-120-08**

## A RESOLUTION AUTHORIZING A LAND LEASE FOR RESIDENTIAL **PURPOSES TO**

- the Mille Lacs Band Assembly is the duly-elected governing body of the Mille WHEREAS. Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS. respectfully requests a land lease for Residential purposes; and
- the lease will be for a period of 25 years and renewable for an additional 25 years, WHEREAS, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- said land is described as follows: WHEREAS.

Part of Tract 410 T 2 located in Section Twenty-nine (29), Township Fortythree North (T43N) Range Twenty-seven West, (R27W) in Vineland Hills Addition, Mille Lacs County, Fourth Principal Meridian, more particularly described as follows:

Commencing at a Global Positioning System (GPS) Coordinate (440,139.08; 5,114,720.35) thence bearing South 0 degrees 00 minutes 00 seconds East a distance of 200.00 feet; thence South 90 degrees 00 minutes 00 seconds West a distance of 200.00 feet; thence North 0 degrees 00 minutes 00 seconds East a distance of 200.00 feet; thence North 90 degrees 00 minutes 00 seconds East a distance of 200.00 feet to GPS Coordinate (440,139.08; 5,114,720.35), to the point of beginning (GPS Coordinates are Universal Transverse Mercator (UTM) Zone 15 NAD 83 Projection Points). The lease site is approximately 1 acre more or less.

NOW, THEREFORE, BE IT RESOI	LVED, that the Mille Lacs Band Assembly hereby
authorizes a land lease	e for the property described herein for residential purposes
be issued to	for a period of 25 years, renewable
for an additional 25 ye	ears subject to the lease provisions, effective upon date of

- BE IT FURTHER RESOLVED, that the lessee will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert to the Mille Lacs Band of Ojibwe; and
- BE IT FURTHER RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1<sup>st</sup> year anniversary of the effective date of the lease without the prior approval of the Band Assembly; and
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 6<sup>th</sup> day of November, 2007 at Hinckley, Minnesota by a vote of AFOR, OAGAINST, OSILENT.
